#### 3. UNFINISHED / OLD BUSINESS

a. Tullamore Sports Complex Naming Discussion ACTION ITEM

Recap: In the summer of 2020 Michael Terrell, the lead architect on the sports field design-led some initial discussion on potential names for the sports complex. This was done as part of the concept and layout of the site. At that time the use of "prairie" in its name was the preferred concept but no firm name came out of the discussion. As the commission and staff had not had time to consider names, we held off a firm selection until more design work was completed.

We have hit that point and have had a bit more time to review what names are around that area and those in conflict. Staff is trying to come up with a wide range of names, but we would welcome and encourage the commission to do the same.

<u>Zibell-Wolfe:</u> The only other idea would be to honor Rick Noordam, he was such an integral part of Parks & Recreation for so many years. Would he qualify?

<u>Fair:</u> He would qualify. Although the Community Garden connects more to Rick than the Sports Complex.

Zibell-Wolfe: He was involved in the Community Garden; I would like to see him honored in some way. So, if the Community Garden is an option, I am good with that.

Robbie Quinn, Parks Planner, Reviewed the images and design for the entrance that was developed during the master planning phase.

Fair: Branding & marketing is going to be critical.

<u>Cornwell:</u> I like The Quarry, if you are trying to do branding the Celtic theme is easy to do.

Noyes: As someone who works in the mining industry, I lean towards The Quarry. I like The Quarry Sports Complex rather than the Sportsplex.

Hail: I ranked my top three and The Quarry Sports Complex was one.

<u>Zibell-Wolfe:</u> Sports Complex needs to be included in the name no matter what it is. If you have interest in a donation and they want naming rights, then you can shorten it to "Donor Name at the Quarry"

<u>Snyder:</u> I like The Quarry, very short. But also like the Sports Complex, not a fan of Sportsplex. Keeping it very short is my thought.

No other discussion

Motion by Zibell-Wolfe to formally name Tullamore sports complex "The Quarry Sports Complex", with permission to shorten it to "The Quarry" for branding purposes.

#### 4. NEW BUSINESS

a. Water Tower Pocket Park Concepts **ACTION ITEM** 

Robbie Quinn, Parks Planner Site is on the corner of McReynolds and Spokane Street, where the water tower is. It is .58 acres, and it is primarily slated to become a public parking lot. As Community Development works with Welch Comer Engineers, this parking lot design will be constructed later this year. In that, they also included the concept designs for the pocket park, so we can ensure they are compatible in the future when we have the funding to build the pocket park portion. Being presented were a couple of concepts that the commission will vote on to move forward to council for their adoption.

Pocket Park Concept A - Radial design

- Existing water tower to remain
- Plaza space with seating under the tower
- Overhead trellis structure to frame plaza
- Terraced seat steps down to turf area
- Stairs to an observation deck
- Water tower observation deck

Pocket Park Concept B – Linear design

- Existing water tower to remain
- Smaller plaza space than the radial design
- Terraced seat steps down
- More lawn turf area space

Open for discussion

Noyes: The big difference between the two is the shape

Quinn: Essentially the radial one has a little bigger footprint for the plaza space

<u>Hail:</u> I like the design of the radial better, I envisioned most of our parks as more linear, so I like the radial and the platforms are one of the coolest things.

Snyder: I agree

Zibell-Wolfe: If you are under the water tower can you see the river?

Quinn: Filtered views right now.

<u>Fair:</u> There is a parcel between this one and the river that someone could potentially build on.

<u>Zibell-Wolfe:</u> For future planning is to add as many park benches as you possibly can there with all the events that are beginning to happen in that corridor.

Quinn: Looking for a recommendation to move to council

#### 5. ADMINISTRATIVE / STAFF REPORTS

**a.** Park Maintenance staff update

Bryan Myers, Parks Manager provides a summary of where we currently stand for available park maintenance staff versus base workload hours. As this is something that is changing day to day. Our biggest impact that is affecting us is coming from our seasonal recruitment. By this time of year, we should be fully staffed for our seasonal staff. Which is typically 12-16 employees. This year we have only had four applicants. We are trying to fill those positions. Our other impact is the ticket booth at Q'emiln Park, we are down to only two employees to cover the shifts and two weeks out to the start. We are between 55-60 percent of our normal available staff hours to operate the parks. Figuring where we can roll back and reduce the impacts on the community. Our staff has met with our routine user groups to help with the general maintenance of fields. Our mow crews are already cutting down to mowing every 10 days instead of weekly. Sports fields went from every 3-4 days to only once a week.

**Duczek:** Are these open positions online?

Myers: Yes, they are.

<u>Fair:</u> Some things we are doing to adjust is for the ticket booth to not operate Monday through Wednesday.

<u>Snyder:</u> What avenues are we using to extend to the public the opportunity to come and work are there some incentives or bonuses at the end of the season?

<u>Fair:</u> The HR department is working on that aspect, and it will be coming forward as part of our budget proposal to the council. With Summer camp counselors we are offering a retention bonus that was approved through the budget process.

<u>Snyder:</u> Possibly a small article or to put on social media, that there is a shortage, and these could be the results. A call to the community to get involved or help where they can.

<u>Fair:</u> We have been using social media to recruit. At a certain point, we must let the community know why they are seeing some of the things that have been cut back.

Myers: With the staffing challenge also affects those volunteer efforts. We don't have the staff to help assist the volunteers.
