Budget - LWCF Request for the City of Post Falls

The Black Bay Park project is a large-scale redevelopment of a 66-acre park. For this phase we are concentrating on 8 acre that were identified by the public as their highest priority. The total estimated cost of this project is \$1,757,086 this a grant request of \$750,000 and city funds paying for the balance.

The cost estimates were developed by Civitas, our contracted design firm and their subcontractors. Detail samples for the boardwalk and the bay restoration have been added but all listed areas can be provided if verification is needed.
