Staff will discuss the options that are being looked at and the ramifications of this popular park amenity. This is for information only and no action is required.
- b) The Landing Avista added a safety line across the river to add another level of safety to anyone who gets past the safety boom. Unfortunately, this anchor system created a safety issue for our park users. We have worked with Avista to resolve this, and staff will cover the proposed fix.
